Finished migration plan – why now?

SAP will discontinue support for SAP Identity Management (IdM) in 2027.



The 4 Steps of the Day One Migration

1 Actual / target state analysis

Tasks: The current status of the SAP IdM implementation is assessed against the established fields of action

for an IAM target model. This includes evaluating compliance with supervisory requirements as well as efficiency criteria. The analysis also covers the current customizing in SAP IdM and collects both functional and non-functional IAM requirements to create use cases for an upcoming Proof of Concept (PoC).

Procedure: Document analysis, workshop and interviews.

Result: Determination of the IAM organization's maturity level and definition of the IAM target model (including

functional and non-functional requirements).

2 Day One Installation

Tasks: Establishment of a tool-based connection to the SAP IdM database through FASTlane reading

all important configurations and transaction data for the Day One Migration.

Procedure: On-site workshop with preparation of the software and review of the configuration and subsequent

migration of data to the new IAM application.

Result: Use of the new IAM application as a PoC / sandbox environment to get to know and try out complete

evaluation of the SAP IdM configuration is available and can be used without access to the system.

3 Trial IAM / PoC

Tasks: Instruction and basic training for the new IAM application. Configuration of existing standardized

settings for better use of the IAM solution.

Procedure: Workshop and discussion of the test version after the first review of the IAM solution.

Defining of the goals of the trial version with documentation.

Result: Customized trial IAM solution reflecting customer-specific requirements.

4 Decision

Tasks: Documentation of the customer review of the IAM after the test phase has been completed.

Support during the decision-making phase for the further use of the IAM and testing in the context of a PoC. Preparation of use cases based on collected functional and non-functional requirements for the new IAM application. Implementation of the PoC based on the IAM.

Procedure: Obtaining a decision regarding a PoC for the IAM and final assessment after implementation of the PoC.

Creation of use cases based on functional and non-functional requirements/implementation of the PoC.

Result: Decision for /against a follow-up project for the introduction of the IAM has been made.
